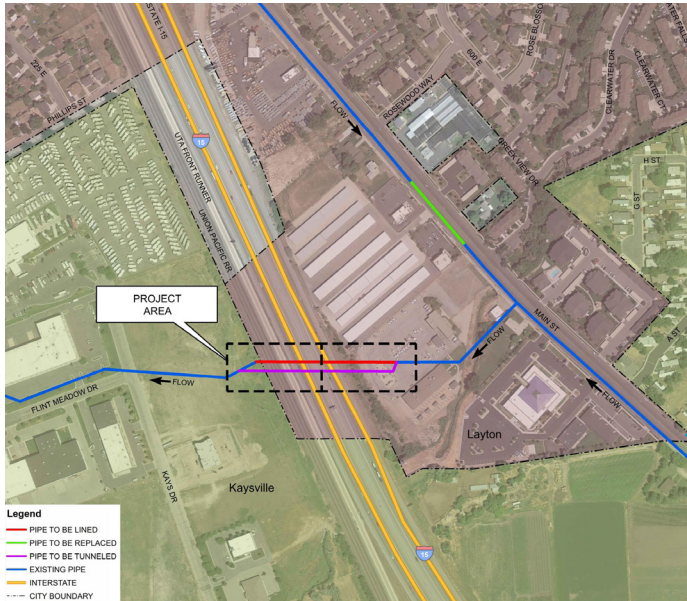




# I-15 Sewer Line Bore and Rehabilitation

Construction under Interstate 15 (I-15) between Kays Drive and Main Street is scheduled to begin this winter and continue into early spring 2018.



### Quick Facts

- What:** Construction of a new sewer line by trenchless boring.
- Where:** Under I-15, approximately 1/2 mile south of I-15 exit 330 for Layton Parkway.
- When:** Construction is anticipated to start early February and continue into Spring 2018.
- Why:** The sewer system is in poor condition and an upsized line is needed to meet the additional capacity in the area.

### Frequently Asked Questions

- Q** Will there be any service interruptions to water, sewer or other services during construction?  
**A** No, water and sewer services will not be interrupted.
- Q** Will driveway access to my business be opened?  
**A** Yes, all driveway access will be maintained throughout construction. The construction may pass in front of a business driveway but access will be maintained. A dedicated Public Outreach Team will coordinate directly with businesses and home owners ahead of this work. See project contact information below and please call or email with any questions.

**Note:** I-15 will remain open during construction. The construction site may be accessed from Kays Drive in Kaysville City and Main Street in Layton City.

### Background and Need

It was determined that the existing 24-inch sewer is in poor condition and does not provide the capacity needs for the population in the area. The main approach to handle the higher capacity needs for the sewer is to upsized the existing line from 24-inch to 30-inch by boring a parallel sewerline under I-15 and the UPRR/UTA railroad tracks.

This is part of an overall effort to upgrade and improve the sewer in Layton City and Kaysville City. This improved infrastructure will support and foster economic development in the area.

### Safety

Safety is a top priority for the North Davis Sewer District. We encourage and appreciate neighborhood participation to keep children away from the construction equipment and work areas. Parents, please talk with your children about staying away from potentially dangerous construction and watching for construction vehicles.
